## Invasive Species Update

The fight against invasive species continues at Torsey Pond. Thanks to volunteers, including the continuing efforts of Andy Zuroski, Torsey Pond continues the monitoring process with good results.

Andy e-mailed an update on invasive species from the Maine Department of Environmental Protection to board members in April. Some edited excerpts follow.

As of Feb. 25, 33 Maine inland waters are infested with invasive aquatic plants. Twenty-seven are infested with variable-leaf water milfoil (*myriophyllum heterophyllum*), two with Eurasian water milfoil (*myriophyllum spicatum*), two with hydrilla (*hydrilla verticillata*), two with curly-leaf pondweed (*potamogeton crispus*) and one with European naiad (*najas minor*). Legion Pond (Kittery) is Maine's only water body to contain two invasive plants: curly-leaf pondweed and European naiad. The latest (2010) infestations documented in Maine are Legion Pond's curly-leaf pondweed and variable-leaf water milfoil in Great Meadow Stream (Belgrade) and Purgatory Stream (Litchfield).

**Salmon Lake (Belgrade):** Four SCUBA surveys of Salmon Lake's Kozy Cove by DEP divers in 2010 found no Eurasian water milfoil since treating the 6-acre cove with herbicide in September 2009. According to DEP and other biologists, it is a matter of when and not if this persistent milfoil species will reemerge; however, the DEP staff and surely Salmon Lake residents are pleased to see this inevitability postponed.

**2010 Courtesy Boat Inspections:** The count's in: DEP reports another bumper year for this important program. The total is 72,428 inspections (15,000 more than in 2009!) and 241 plant interceptions leaving infested lakes. Forty invasive plants were removed from boats prior to entering lakes (four of which were uninfested)! Participating lake associations, volunteers and others can be assured of two things: the word's out about invasive plant prevention. Every new invasive plant caught at a boat ramp is one less opportunity for a favorite lake to become infested.

**Grant Money Update:** The news is good for these belt-tightening times. Cost share grants for 2011 Courtesy Boat Inspections remain at \$95,000. Plant management cost share grants are also locked in at \$70,000. Both amounts are unchanged from 2010. These funds are generated from Lake and River Protection sticker sales with limited federal support by U.S. Fish and Wildlife Service

## PROPOSED AMENDMENT TO THE TORSEY POND ASSOCIATION BYLAWS

On July 23, 2010, Mark Dershwitz, Don Rahmlow and Linda Lally met with attorney Norman Rattey. Rattey strongly urged that the Torsey Pond Association adopt the following amendment to the current bylaws. The amendment will be brought before the membership at the annual meeting on July 9, 2011.

### ARTICLE

#### Indemnification

The doing of any act or the failure to do any act by a director, officer, or member at the request of the Association, serving on a committee on behalf of the Association ("committee member"), the effect which act or failure to act may cause or result in loss or damage to the Association or its property, shall not subject the said director, officer, or committee member to any personal liability to the Association or the other members, unless the director, officer, or committee member's acts or omissions constituted bad faith, gross negligence, willful misconduct, fraud, or a material violation of these bylaws. In addition, the Association shall indemnify its directors, officers, and committee members and make advances for expenses incurred in defense of claims of liability to the maximum extent permitted under the Maine Nonprofit Corporations Act. The Association shall indemnify its other members who are not directors, officers, or committee members to the fullest extent permitted by law provided that such indemnification is first approved by the Board of Directors. The right to indemnification under these bylaws shall be fully vested with respect to any matter. No amendment to these bylaws shall have any retroactive effect except to enhance such right for the benefit of the indemnitee.
